We process personal data and have therefore made this privacy policy, which tells you how we process your personal data to ensure a fair and transparent processing.

Consistent with our data processing is that we only process personal data for certain purposes and on the basis of legitimate interests. We process personal information which is relevant and necessary for the fulfillment of the stated purposes, and we delete your information when it is no longer needed.

Processing of personal data

We process the following personal information:

General personal information:

Registration and contact information such as name, gender, address, registration date, telephone number, date of birth and e-mail address.

Where do we collect information from?

Usually, we get the information directly from you.

The Club's purpose for processing of your personal data

We process your personal data for specific purposes when we have a legal reason.

Legal reasons for using your personal data:

- The Club's legitimate interests in processing your personal data.
- According to legal requirements.
- With Your consent.

The purpose of using members personal data:

- Collecting membership fees.
- Part of the Club activities.
- Compliance with legal requirements, including the Public Information Act.
- Administration of your relationships with the Club.

We only process personal data in regard to legitimate interests

To the extent that we use your membership information on the basis of the balance of interests' rule, this processing will be motivated solely by legitimate interests:

- Activities, including preparation of team line-ups, internal result lists, etc.
- Management of your membership rights according to club bylaws.
- Fulfillment of membership obligations, including collection and payment of membership fees, etc.
- Hosting social events.
- Use of photos taken in the club settings which depict a specific activity or situation in the club.
- Disclosure of your general personal information to organisations and associations to the relevant and necessary extent in connection with club activities.
- For practical and administrative reasons, we also store your general membership information for a period after your resignation from the club
- Storage of information with historical value for statistics and the like.

Your consent

Most often, our processing of your personal data will be based on a legal basis other than Your consent. We therefore only obtain Your consent when, in rare cases, it is necessary to process your personal data for the purposes described above.

If we obtain Your consent, it is voluntary if you want to give consent, and you can withdraw it at any time by notifying us.

Disclosure of your personal information

In connection with activities, information on participation and results is passed on to relevant organizations.

Storage and deletion of your personal information

As a member, we store your personal information for a period from the end of the membership and in accordance with the following criteria:

- For practical and administrative reasons, we store your general membership information for up to 1 year from your resignation from the club

Your rights

You have several rights under the Personal Data Ordinance when we process personal data about you:

- The right to be informed about the processing of data.
- The right to access personal information.
- The right to rectification.
- The right to delete.
- The right to restrict use of personal information.
- The right to data portability (provision of data in a commonly used format).
- The right to objection.

You can make use of your rights, including objecting to our handling of data, by contacting us. Our contact information can be found at the top of this document.

For example, if you request to have your personal information corrected or deleted, we will investigate whether the conditions are met, and if so, implement the change or deletion as soon as possible.

You can lodge a complaint with the Data Protection Authority, e.g. Datatilsynet, at any time.

We reserve the right to make changes to this Privacy Policy from time to time. In the event of changes, the date at the top of the Privacy Policy will be changed. The privacy policy in force at any time will be available on our website. In the event of significant changes, you will be notified.
